- **Do not** include original documents such as photographs, passport or medical reports. You should provide A4-size photocopies. If original documents are required, we will request these during the visa assessment.
- Processing of applications will be delayed if lodged without complete documentation.

Copy of the passport photo page for all applicants included in the application.	
1 passport sized photo of each applicant affixed to the front of the application form.	
Copy of the live birth certificate for each applicant from the Philippine Statistics Authority (PSA, formerly NSO) AND copy of PSA 'Certificate of No Marriage' (CENOMAR) for applicants over 18 <i>If you do not have PSA/NSO documents, you must request these through the ecensus website</i>

If birth was late-registered, copy of applicant's baptismal certificate and elementary school record	
For applicants 17 years and over, police clearance from each country you have lived in for 12 months or more during the past 10 years since turning 16 years of age	
For applicants 18 years and over:	
 evidence that you are financially dependent on your sponsor for your basic needs of food, shelter and clothing and how long this support has been provided 	
 evidence of your enrolment and active participation in a post-secondary course of study and evidence of all studies undertaken since turning 18 years of age 	
If the 18+ year old child is not a full time student, a written explanation of why they are not studying	

SPONSOR		
Evidence that the sponsor is an Australian citizen, permanent resident, or eligible New Zealand citizen (eg passport copy)		
A recent passport-sized photograph of the sponsor with their name written on the back of the photo		
If the applicant is under 18 years of age:		
 an Australian National Police Check for the sponsor, if the sponsor has spent a total of 12 months or more in Australia since turning 16 years of age 		
 penal (police) clearances from each country in which the sponsor has spent a total of 12 months or more in the last 10 years since turning 16 years of age

If the applicant is under 18 years of age, and the sponsor has a spouse or de facto partner, that partner must provide the following:		
 an Australian National Police Check if the person has spent a total of 12 months or more in Australia since turning 16 years of age 		
 penal (police) clearances from each country in which the sponsor has spent a total of 12 months or more in the last 10 years since turning 16 years of age
